Test Site Information

The run-throughs will be inside a garage with a cement floor. There is no indoor crating space. Dogs must be crated in your care until they are called to run. The parking (on grass) has no shade. Bring shade as needed. Restrooms are a “porta-johns.” **Please clean up after your dog, as this is a private residence. Exhibitors violating this rule will be asked to leave. Receptacles will be provided for disposal of waste. All dogs must be walked on a 6’ leash.**

Entry Requirements

Two (2) dog limit. Please fill out a separate entry form for each dog.

Closing Date and Refunds

Entries and payment must be received at the Secretary’s address no later than Friday, 04/28/2017. Cancellations must be made before 04/28/2017 at 5:00pm and will be refunded minus a \$10.00 cancellation fee. No refunds after the closing date. Cancellations may be made by email (cagartland@gmail.com). Entries fees will not be refunded if dog is absent, disqualified, or excused by the judging official.

Video/Photography

Run-through participants are allowed to have a friend or family member video/photograph their test. Participants who have completed their run may be allowed to video another competitor for training purposes.

BASIC DESCRIPTION OF TEST: The Container search element tests a dog’s ability to locate the target odor(s), which is/are hidden in one or more containers within a search area, and communicate the find to the handler. A container can be a cardboard box, a paper bag, an upside down flower pot, a back pack, a briefcase, a storage bin, a trash can, a piece of luggage, etc., as required by difficulty level. This test will be conducted inside, on leash.

RUN ORDER: Elements will be run in the following order

1. Novice (Birch)
2. Advanced (Birch and/or Anise)
3. Excellent (Birch and/or Anise and/or Clove)
